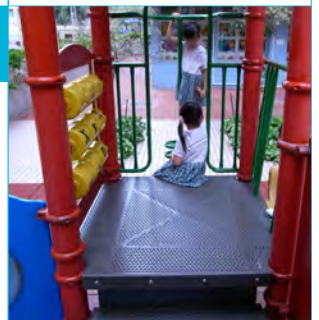
## 2. Playground/Playroom Safety Inspection\*
